

# **CITY OF VON ORMY, TEXAS**

## **RESOLUTION NO: 2008-2**

---

### **A RESOLUTION DETERMINING THAT IT IS ADVISABLE TO JOIN THE TEXAS MUNICIPAL LEAGUE; AND AUTHORIZING THE MAYOR TO TAKE ALL ACTION NECESSARY TO JOIN THE TEXAS MUNICIPAL LEAGUE.**

**WHEREAS**, the City Council of the City of Von Ormy has determined that the Texas Municipal League ("the TML") exists solely to provide services to Texas cities. Since its formation in 1913, the League's mission has remained the same: to serve the needs and advocate the interests of its members; and

**WHEREAS**, The TML constitution states that the purpose of the League is to "render services which individual cities have neither time, money nor strength to do alone;" and

**WHEREAS**, the TML's Service Statements are:

- Represent the interests of member cities before state and federal legislative, administrative, and judicial bodies at the state and federal levels.
- Conduct and sponsor an annual conference and other educational events to facilitate the study and exchange of information on relevant city government issues.
- Publish and circulate an official magazine and other publications, reports, and newsletters of interest to member cities.
- Alert member cities to important governmental or private sector actions or proposed actions which may affect city operations.
- Promote the interests of League affiliates (departments) and regions by providing organizational and technical assistance as directed by the Board and consistent with financial resources.
- Promote constructive and cooperative relationships among cities and between the League and governmental entities, councils of governments, the National League of Cities, educational institutions, and the private sector.
- Provide in a timely manner any additional services or information which individual members may request, consistent with the member cities' common interests and the League's resources.
- Provide administrative services to the League's risk pools so that quality coverages at reasonable and competitive prices are available to member cities and their employees; and

**WHEREAS**, the City Council of the City of Von Ormy desires to join the TML; and

**WHEREAS**, the TML has offered the City membership for one year at no cost; and

**WHEREAS**, the City Council of the City of Von Ormy find it advisable and prudent to allow the Mayor to take all action necessary to join the TML.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF VON ORMY, TEXAS** as follows:


**Section 1.** That the City Council hereby determines, in its discretion, that is advisable to join the Texas Municipal League.

**Section 3.** That this resolution shall become effective immediately upon its passage.


**PASSED, APPROVED, AND ADOPTED** this 19<sup>th</sup> of November 2008.
